OBJECTIVES

- 1. To promote products of HKTDC Hong Kong Toys & Games Fair 2013 and Hong Kong Baby Products Fair 2013 to international buyers
- 2. To highlight toys and baby products of superb quality and design

CATEGORIES

Open to exhibitors of Toys Fair:

- 1. Educational Toys & Games
- 2. Electronic & Remote Control Toys
- 3. Kidult Toys (for grown-ups)
- 4. Outdoor & Sporting Items

Open to exhibitors of Baby Products Fair:

- 5. Baby Toys & Activity
- 6. Baby Wear & Footwear
- 7. Feeding, Maternity and Baby Care Products
- 8. Nursery Electrical Appliances
- 9. Strollers & Gear

RULES AND REGULATIONS

- 1. The Competition is exclusively open to exhibitors of the HKTDC Hong Kong Toys and Games Fair 2013 and HKTDC Hong Kong Baby Products Fair 2013.
- 2. Each company may submit a maximum of 3 entries.
- 3. Contestants must submit a completed application form, product sample, and the required information. Incomplete application will not be considered.
- 4. The Organiser has absolute discretion in the admission of applicants.
- 5. The Organiser will exercise maximum care in handling all entries. However, the Organiser will assume no liability for any damage or loss of any kind.
- 6. The Organiser will not be held responsible for infringement of copyright or patent law connected with the products entered in the Competition.
- 7. The Organiser will retain the right of printing, publishing and exhibiting the winning entries and other selected entries at its discretion.
- 8. The Organiser reserves the right to disqualify any contestants in breach of the rules and regulations listed above.

DEADLINE FOR SUBMISSION OF ENTRIES

All application forms and product samples must reach Exhibitions Department, Hong Kong Trade Development Council, Unit 13, Expo Galleria, HKCEC, 1 Expo Drive, Wan Chai, Hong Kong on or before 27 November 2012 (Tuesday).

JUDGING CRITERIA

The judging is based on:

- Innovation
- Functionality & Safety
- Marketability

The decision of the judging panel will be final.

ANNOUNCEMENT OF RESULT

- 1. Official announcement of result and presentation of awards will be made at the HKTDC Hong Kong Toys and Games Fair 2013 and HKTDC Hong Kong Baby Products Fair 2013.
- 2. All entries (except those winning ones) will be available for collection within one week from the date of announcement of the competition result. Submissions which are not collected within the specified time will be disposed of by the Organiser as deemed fit.

ECO AWARD

The judging panel will select ONE product which is most eco-friendly in terms of the overall concept, use of materials and production process.

A trophy and a cash prize of HK\$2,000 will be presented to the winner of Eco Award.

HONG KONG DESIGN AWARD

The judging panel will select ONE product among all Hong Kong entries which is most innovative and impressive in design. A trophy will be presented to the winner of Hong Kong Design Award.

Other Prizes

- 1. The winning pieces and selected products will be displayed at the HKTDC Hong Kong Toys & Games Fair 2013 and HKTDC Hong Kong Baby Products Fair 2013. They will also be publicised in the fair websites and other promotional materials of the fairs.
- 2. The winning companies will be invited to join networking events, including the prize presentation session, to meet with buyers and media.
- 3. The winning companies may use the logo of the Competition for further promotion of their winning pieces.
- 4. The Organiser reserves the right to withhold granting of any of the awards if the entries do not meet the desired standard.
